What Is Document Auto-Processing?

Document Auto-Processing automatically processes correspondence from some of the world's largest PTO offices using Microsoft Azure AI Document Intelligence. With this capability, you can auto-process the PTO forms you receive daily, including 400 USPTO forms, 450 EPO forms, and more.

AQX supports auto-processing for close to 100 trademark documents from the USPTO.

By focusing on the PTO documents that have the highest frequency, Document Auto-Processing can greatly reduce the total docketing workload.

The Document Auto-Processing capability can automatically:

- 1. Scan PTO documents and identify the type of document
- 2. Extract bibliographic information and statutory deadlines
- 3. Assign information to relevant IP records
- 4. Provide visibility and control of data updates and validation processes

What is an example of automatically processing a docketing task?

When you receive an e-office notification, Document Auto-Processing capability scans the incoming document from the USPTO. It then automatically extracts and enters your data into AQX. Using the additional validation screen, you can easily control the validation process and improve accuracy.
