Firms are embracing cloud-based applications, integration technologies, and collaboration tools to keep remote workers, clients, and business partners connected and working efficiently.

Integrating the firm's essential systems helps IT combat the significant time and money investment required to maintain separate systems. Connecting systems simplifies user's workflow while keeping content in a centralized location.

Streamline IP management workflow with connectivity to your firms' other essential systems.

PATTSY WAVE Sync enables you to securely integrate Anaqua's PATTSY WAVE with your document management system (DMS) or file management system. PATTSY WAVE Sync is an API-based enterprise content synchronization solution designed to automate processes, support internal and external collaboration, and help improve Information Governance and data compliance.

Build in Efficiency - Integrate and Automate

Users can conveniently collaborate by working as they normally do, either in the PATTSY WAVE application, or in the DMS, with content, such as matters and their associated documents and metadata. PATTSY WAVE Sync works in the background, automatically synchronizing any document updates or new documents added to the corresponding location in the opposite system, on an ongoing, and scheduled basis.

As new matters are created in PATTSY WAVE, they are automatically detected by PATTSY WAVE Sync and it searches for the appropriate DMS workspace based on client and matter metadata. If found, it then searches for the corresponding PATTSY WAVE folder within the workspace. If found, the two spaces are connected and a content sync begins. If no workspace or folder is found, PATTSY WAVE Sync automatically creates a new workspace with the appropriate PATTSY WAVE folder, and begins the sync process.

Firms can configure the integration to keep only stub files of documents in PATTSY WAVE, essentially archiving the actual up-to-date documents to the DMS to maintain one source of truth. Users can still access and edit documents that reside in the DMS from within PATTSY WAVE, taking advantage of the native DMS versioning and functionality.

Manage Content

- Manage content between your systems (on-premise, hybrid, cloud).
- Maintain full administrative oversight and control of sync rules using the Management Studio.
- Sync content one-direction (archive from PATTSY WAVE to the DMS), or in two-directions between the systems. Works with iManage and NetDocuments.
- Edit documents while working in PATTSY WAVE, with DMS functionality and versioning.

Automate Processes

- Upon initial implementation, and as new matters are added, PATTSY WAVE Sync automatically creates a DMS workspace for each PATTSY WAVE matter and a PATTSY WAVE sync folder within each workspace (or, if a workspace already exists, it creates the PATTSY WAVE folder and begins the content sync).
- Automatically sync matter content, metadata, and security between PATTSY WAVE and your DMS or file management system on an ongoing basis, scheduled basis (configure to run every one minute or longer).
- Complements PATTSY WAVE's AutoDocket® &
 Download feature which detects documents in
 your USPTO Private PAIR and TSDR portfolios.
 Then it automatically downloads the corresponding
 documents to the respective matters and dockets
 the necessary reminders. With the DMS integration,
 these documents are subsequently synced to the
 corresponding workspace in your DMS.

Configurable Options

Archive content from PATTSY WAVE to the DMS or file sharing system, keeping only a stub file in PATTSY WAVE that links to the document in the DMS for editing.

Or, sync the documents to both systems and leave stub files in the PATTSY WAVE matter for editing.
