## What prompted your interest in exploring new IP management technology?

**Mikkel Lassen Ellingsen (MLE):** At my previous firm, we used one of the older, on-premise systems—what I jokingly call a “dinosaur” platform. It was powerful but slow, and deeply embedded in the firm’s processes. I was always curious about innovation in the space, and when I moved to CMS Kluge, I saw an opportunity to start fresh. We were managing some trademark records in Excel, which wasn’t sustainable. That’s when I reached out to explore options, including RightHub from Anaqua.

## What were you looking for in a new IP management system?

**MLE:** We needed something lean, intuitive, and cost-effective. Our team is small—just me and a paralegal—so usability was critical. We didn’t have the resources for extensive training or IT support. The system had to be plug-and-play, with functionality that anyone could pick up on day one. We were definitely looking for functionality your grandmother could have used.

## How did the onboarding process go with RightHub from Anaqua?

**MLE:** It was quick and pain-free. We started with a small portfolio—20 to 50 records—and were able to onboard ourselves. The platform was intuitive, with drag-and-drop functionality and clear workflows. We had one or two training sessions, but honestly, that was all we needed. The system just worked.

## What does day-to-day use of the platform look like for your team?

**MLE:** It gives us full control over deadlines, which is the most important part. We use it for docketing, renewals, and basic portfolio management. It’s a low-cost, accessible way to maintain our clients’ rights safely and efficiently. We’ve also started exploring collaborative features, like granting clients access to their portfolios. Some clients love that transparency; others prefer the traditional email approach. Flexibility is key.

## What do you see as the future of collaboration in IP management?

**MLE:** The ability to communicate with agents and clients within the platform is promising. It streamlines processes and reduces duplication. As the industry evolves, I think we'll see more firms embracing leaner, more scalable solutions. As I said during the webinar:

The market needs to get leaner. It needs to increase profitability. And the way you do that is by finding software that's cheaper but still does most of what your expensive software does now.

## Are you optimistic about the role of AI in IP management?

**MLE:** AI isn't here to replace the fun parts of our jobs—it's here to eliminate the boring stuff. That's a message that resonates with our team and encourages adoption.
